What is an HMRC investigation?

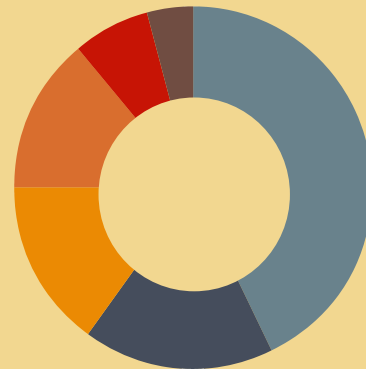
